Sub: Intimation under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015

This has reference to our earlier communication today, vide which we informed that the Income Tax Department has concluded its search at our office premises and manufacturing plants.

In this regard we would like to further inform that the operations at the manufacturing plants of the Company were disrupted from 22nd November 2023 (afternoon) to 26th November 2023 for Bengaluru location and 21st November 2023 to 23rd November 2023 for the Baddi location.

Manufacturing operations at our Bengaluru plant have fully resumed from 27th November 2023 and for the Baddi plant from 24th November 2023.

All our employees and factory workers have resumed work with full zeal and sales & manufacturing operations are completely normalized.

Since IT & communications systems were disrupted, we regret the delay in communicating the same to stock exchanges.
